The Baseball Building

Dyersville IA



Property History

The property was originally developed in 1891 as a brewery which it remained until it was sold and converted to an iron works/machine shop and gasoline engine repair shop in 1915. From 1929 to 1964 the property was used for multi-residential and a portion was vacant. Tegeler Dairy operated at this site from 1977-2010 along with a portion utilized for multi-residential. The property was underutilized and has sat primarily vacant since 2010.

Three of the four buildings along 2nd St SE were built circa 1900 and total 5,042 square feet and the end building was built around 1967 and provided an additional 1,456 square feet. In 1988 a 4,080 square foot metal warehouse building was built behind the street front properties. Total improvements: 10,578 square feet.

The City of Dyersville identified the site as being underutilized and in need of repair. Dyersville Industries Inc. a potential purchaser of property utilized U.S. EPA Brownfields Assessment grant funds in 2019 from ECIA Brownfields Coalition to obtain a Phase I Environmental Site Assessment on the property. The assessment indicated based on prior use of the site and visible mold, lead based paint and possibly asbestos that further testing be conducted prior to redevelopment of the property.

The property owner at the time decided to sell the site privately. The site was sold on October 15, 2020 to current owner.

Redevelopment

The City applied and was awarded an IEDA Community Catalyst Building and Remediation Grant for \$100,000 to assist a potential developer with redevelopment of the property. As part of the grant the City provided local match of \$25,000 towards the project.

The new property owner converted the buildings into a retail store, museum and baseball batting cages and training facility. The If You Build It Exhibit occupies one of the buildings contains an exhibit dedicated to the Field of Dreams movie and film location. The City of Dyersville contributed \$100,000 from the city’s federal American Rescue Plan Act money towards retooling exhibit pieces the museum had own prior to relocating to this building. 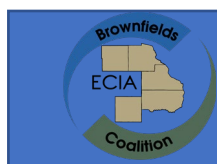
